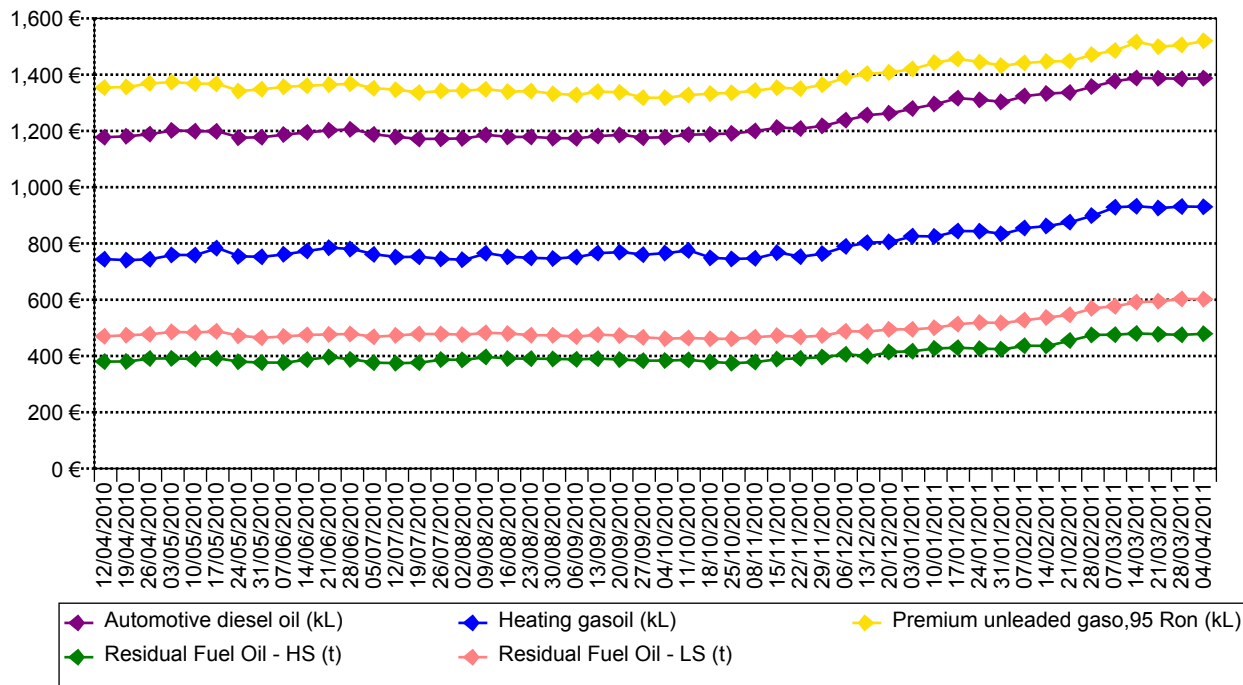



GEWICHTETER DURCHSCHNITT - EUR 27




