- at least 1 welder with suitable certification for fabrication of equipment for use in the nuclear industry; proof of this certification is required at the time of tender,
- at least a mechanical engineer with more than 3 years' professional experience.
- c. Evidence:

The following evidence should be provided to fulfil the above criteria:

- a list of relevant services provided in the past 3 years, with sums, dates and recipients, public or private. The most important services shall be accompanied by certificates of satisfactory execution, specifying that they have been carried out in a professional manner and have been fully completed,
- the educational and professional qualifications (CVs) of the persons who will provide the service for this tender, including the management staff. Each CV provided should indicate the intended function in the delivery of the service,
- either copies of the licences/certifications enabling the tenderer to machine materials with toxic properties such as lead, cadmium and tungsten,
- or a list of examples of manufacturing components based on Plexiglas or Makrolon, PE and materials with toxic properties such as lead, cadmium and tungsten.
