Reporting price discounts on motor fuels	Average consumer prices reported take into account possible discount prices at filling stations offered by distributors to consumers.
Market coverage and data sources	<ul style="list-style-type: none"> <li>Data collected from 24 oil operators, including 5 oil companies, 7 large store chains and 12 independent groups. LPG prices provided by 10 companies.</li> <li>The operators surveyed account for 92% of volumes of motor fuels sold in the distribution network (Euro Super 95 : 94% ; Euro Super 95-E10 : 99% ; Euro Super 98 : 97%, Diesel : 91%), 71% of heating oil and 56% of heavy fuel oil.</li> </ul>
Price averages	Weighted average with weights defined based on the market share of each operator (oil companies, large store chains, independents).
Biofuels	<p>To incentivize biofuels development and blending into motor fuels, the motor fuel tax system is based on two elements taken into account by operators in the calculation of pump prices at the filling stations:</p> <ul style="list-style-type: none"> <li>a partial tax exemption of "TICPE" (Taxe Intérieure de Consommation sur les Produits Energétiques) granted to sustainable biofuels produced by production units that have received an administrative agreement (the administrative agreement is given by the General Directorate of Customs, after a EU bidding procedure), in the limit of quantities fixed by the agreement ;</li> <li>an additional tax named "TGAP" (Taxe Générale sur les Activités Polluantes) paid by operators who are putting on the market fuels that don't reach the minimal threshold of 7% energy incorporated biofuels.</li> </ul> <p>Biofuel contents of fuels : maximum content of biofuel in automotive fuels is fixed by law :</p> <ul style="list-style-type: none"> <li>Euro super 95 : max 5% volume of ethanol.</li> <li>Diesel : max 7% volume of FAME (biodiesel).</li> <li>Heating oil (gas-oil) : max 7% volume of FAME (biodiesel).</li> </ul> <p>No differentiated taxation (excise duties) for biofuel blends.</p> <p>The excise duties reported by France (691.40 €/1000l for Euro Super 95 and 609.50 €/1000l for diesel oil as of 01/01/2018) are the weighted average excise duties, taking into account the regional excise duties weighed by regional oil consumptions.</p>

Other specific remarks by national administrations	<ul style="list-style-type: none"> <li>High degree of consolidation in the refining sector in recent years.</li> <li>High competition in the retail oil market with significant penetration of large store chains since the late 1980's.
