
Background:

As part of the "Smart Finance for Smart Buildings" initiative, the European Commission is organising a series of "Sustainable Energy Investment Forums" (SEI Forums) to enhance the capacity of and cooperation between public and private stakeholders to develop large-scale investment programmes and financing schemes.

Since 2016, SEI Forums has organised over 30 events covering many EU Member States. These included public conferences which are open, often with a regional scope, national roundtables (upon invitation) that focus on national or regional circumstances and follow up events according to identified needs and opportunities.

The objective of the first SEI Forums National Roundtable in Finland is to foster a dialogue between key stakeholders on how to improve access to finance for energy efficiency investments, and to identify common objectives and potential improvements to be made in the current policy framework and business practices. The Roundtable will devote a significant amount of time to exchanges and interaction between participants in the form of parallel thematic sessions. Presentations and materials from the sessions will be made available to all participants, as will be the results of the thematic sessions.
