 - new growth models.

To upgrade existing collaborations, established through year in several levels and topics into a common agenda and understanding contributing to the smooth and viable regional transition processes as well as technological development and innovation.



To develop clear and robust solutions for new skills and competitive business sectors in a rather short time period replacing economic models and technological concepts build in decades or even centuries.

- Open access to citizens / public awareness increase on transition process









Proposed next steps for the establishment of an inter-regional dialogue



- Establishment of a task force to formulate the framework of the inter-regional dialogue / contacting and identifying trends among regional stakeholders / preparation by the task force of a proposal for the inter-regional dialogue structure and governance
- Mapping of Regional transition needs and requirements / synergies and opportunities for collaboration
- Collaboration of CPiT, task force and other active technology and policy stakeholders involved (JRC, World Bank, etc) on topics determination enriching inter-regional dialogue
- Selection of criteria, such as impact on employment, maturity of implementation, and coherence with regional / EC policies for an effective and successful dialogue
- Replication potential to other Regions towards EC decarbonisation process
