


#### **Resources and approach**

Workplans developed
Now delivering support (adapted to Covid-19 circumstances)





## Just Transition

Kieran Mulvey Commissioner My Terms of Reference....

Help ensure a coordinated and effective approach to Just Transition, focusing initially on communities and workers affected by the ending of peat harvesting for power generation in the Midlands region.

A coordinated, long-term, and multi-pronged response involving social partners, industry, and Government, whilst taking account of relevant existing plans and programmes by the State as well as provisions made in Budget 2020 to support a Just Transition

To engage with all relevant stakeholders

To make recommendations on the essential elements of a Just Transition for workers and communities most affected, including through:

Delivery of the Just Transition measures provided for in Budget 2020,

Implementation of other actions underway, or planned, by Government Departments, Agencies, and Companies, including the four competitive funds under Project Ireland 2040;

Optimal structures or processes to support co-ordinated and effective delivery of a Just Transition in the Midlands, including developing liaison channels between institutions in the region and central





#### Progress Report November 2019 – April 2020



- Willingness within the region to collaborate

Detailed JTF Criteria from DCCAE on June 15<sup>th</sup> Projects to commence in late July/ early August Ensure draw down of Budget 2020 measures dedicated to the Midland Region Government Detailed Implementation Plan due end of June 2020 **European Just Transition Fund** Convene MRTT Working Groups **Risks** – must acknowledge and ask for your support in terms of identifying a mechanism to enable the spend of funds identified in Budget 2020 to be permitted spend into 2021, however an inability to spend in 2020, does not bode well for Budget 2021 ask of €25M


